In the announcement of the transaction, Altera co-founder Robert Yang said, "It has been my life goal as a neuroscientist to go all the way and build a digital human being —redefining what we thought AI was capable of. Our solidly pro-human framework means that we are building agents that will enhance humanity, not replace it."


