

BeHeard Announced As One of 18 Startups for Anthology Fund and New Financing

Gunderson Dettmer client BeHeard, an AI-driven customer feedback platform, announces its pre-seed financing and selection as one of the first 18 startups backed by Menlo Ventures and Anthropic's \$100 million Anthology Fund. BeHeard uses AI agents to gather deep insights throughout the customer journey, direct executives to improve their offerings and boost revenues. The pre-seed also included participation from True Ventures, Ridge Ventures and Sterling Road.

According to the TechCrunch announcement, "Menlo says these first 18 were selected from thousands of applicants. They include startups working on recruiting software; autonomous coding; interpretability research (understanding how models make decisions); fintech compliance and tax apps; radiology image analysis and chart reviewing apps; non-human identity cybersecurity; customer engagement software; and a consumer nutrition app."


