In the announcement of the transaction, HDVI co-founder and now CEO Reid Spitz said, "I saw an opportunity to bring trucking and insurance together and provide real innovation. The core methods used for pricing and underwriting trucking companies hadn't changed. At the same time, there had been a tremendous amount of innovation happening in technology. Now, we are using telematics data to better price, underwrite and give fleets more flexibility in how they can control their own insurance costs."
