- Gunderson Dettmer represented client Seedz, an agtech customer engagement platform, in its \$16.5 million Series A financing led by Alexia Ventures.

"Market conditions continued to be challenging through the end of 2022, but we are optimistic about the year ahead. We see venture fund clients planning to raise new capital for investment in the region, and early-stage financing activity remains steady. Moreover, in challenging environments like the current one, we believe companies benefit more from our firm's decades of experience in the venture capital industry, including through previous downturns," added Brian Hutchings, Co-leader of the Latin America practice.
