

PitchBook 2022 Global League Tables Confirms Gunderson Dettmer as the #1 VC Law Firm for Ninth Consecutive Year

For the ninth consecutive year, Gunderson Dettmer has once again been named the top venture capital law firm globally by PitchBook. Over 2022, Gunderson Dettmer was credited with a total of 1694 venture and growth equity financings worldwide, raising over \$80 billion for technology and life sciences companies.

PitchBook's Global League Tables categorizes financings across venture stages, industries and regions, and Gunderson Dettmer secured the top spot in 21 of those categories – notably the Global, United States, Rest of the World, Early Stage and Late Stage categories.

Market Leadership in All of Its Home Markets

Gunderson Dettmer's market leadership is undisputed, as the firm has been ranked as the #1 VC law firm in their respective regions across all 11 of their global offices. With offices located in Silicon Valley, San Francisco, New York, Austin, Ann Arbor, Boston, San Diego, Los Angeles, Singapore, Beijing, and Sao Paulo, this exceptional level of recognition is a testament to the firm's deep involvement in each market, as well as their close working relationships with venture capitalists and companies at all stages of growth.

Dominance Throughout the Lifecycle

Gunderson Dettmer was also ranked the #1 law firm for early stage financings and late stage financings. PitchBook credited the firm with 630 early stage and 615 late stage financings, along with 71 exits ranging from mergers of equals to strategic multi-billion acquisitions. This recognition confirmed the firm's extensive experience working with startups, emerging companies, late-stage venture-backed companies and public tech companies on the range of legal challenges faced by companies at all stages of growth.

Continued Leadership in Tech and Life Sciences

Gunderson Dettmer's top recognition in the software category, where it was credited with 937 financings, is a testament to the firm's deep roots in the tech industry. The firm was also ranked highly in the three life-sciences-related categories – Pharma and Biotech, Healthcare Devices and Supplies and Healthcare Services and Systems – which demonstrates Gunderson Dettmer's continued focus on the industry.
