- Massachusetts paid family and medical leave act updates, and increasingly challenging Wage Act;
- California CPRA, leave laws, and changes to exemption thresholds;
- California's AB 51 & the federal Ending Forced Arbitration of Sexual Assault & Sexual Harassment Act;
- The Speak Out Act;

- The EEOC's evolving policies and recommendations regarding COVID-19;
- Challenges relating to remote and distributed workforces;
- ESG Environmental, Social, and Governance initiatives, including Diversity & Inclusion policies; and
- Independent contractors and changing rules under the Biden Administration.
