The Gunderson Dettmer deal team was led by Andy Bradley and included Amy Luong, Bailey McQuain, Anna Westfelt, and Alice Lu.

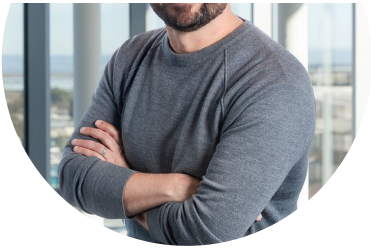
