Gunderson Dettmer finished the second quarter of 2022 as the “most active VC law firm globally” in [PitchBook’s Global Venture Capital League Tables](#).

Highlights

- **Confirmed reputation.** The firm was ranked as the top VC law firm in 19 categories – including global, software and several regional and international categories. Gunderson Dettmer represented its clients in 421 global financings valued at more than \$23 billion in Q2 alone, and when considering the first half of 2022, Gunderson Dettmer leads the world with 913 financings valued at over \$55 billion raised for high-growth emerging companies globally.
- **Lifecycle expertise.** Gunderson Dettmer earned a #1 ranking in categories across the company lifecycle – from early-stage financings to exits. Its work in early stage financings, notably, infused over \$6.5 billion into startups around the world.
- **International excellence.** The firm is the dominant law firm for financings in Latin America and Asia and is recognized for representing both investors and companies.
