

Nebulock Emerges from Stealth with 8.5M Series Seed Financing

Gunderson Dettmer represented client Nebulock, an AI-enabled threat hunting platform, in its emergence from stealth mode and the announcement of its \$8.5 million Series Seed financing led by Bain Capital Ventures. Nebulock actively scans and responds to malicious activity on a company's system. The new financing will be used to hire more engineers and sales and marketing employees and also build out the platform to expand the types of threats it can detect.

In the announcement of the transaction, Nebulock founder and CEO Damien Lewke said that while in stealth, Nebulock tested its products with a variety of customers across health tech companies, banks and VC-backed technology firms. He added, "Our vision is to have Nebulock be that teammate that tips the balance of power back in the hands of network defenders."
