We support the entrepreneur with starting a business, accounting and business management, and we don’t just have a system in which he enters data and then hires an accountant to take care of the information. In recent years, we have opened services that went beyond the website, such as telephone and WhatsApp conversations. With the physical stores, we reach even more entrepreneurs.”
