

# Brazil-Based Darwin AI Announces \$4.5M in Additional Seed Financing

Gunderson Dettmer represented client Darwin AI, a Brazil-based provider of AI workers for sales, customer support and post-sales processes, in its additional \$4.5 million seed financing led by Base10 Partners. The round brings the company's total funding to \$7 million.

**Founded in July 2023** by Lautaro Schiaffino and Ezequiel Sculli, Darwin AI develops intelligent agents that collaborate with human workers to answer questions, provide assistance, and drive efficiency and growth. Today, Darwin integrates with leading communication channels including WhatsApp, Instagram, and phone.

The new capital will be used to accelerate growth across Latin America and to advance product development efforts focused on building AI workers for mid-market companies.

The Gunderson deal team was led by Dan Green and included Federico Varni.

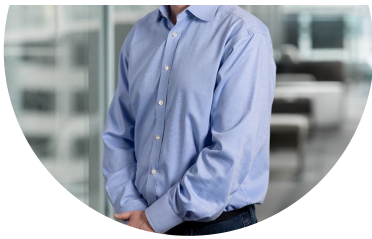
