The latest financing is the largest funding round in the security industry and values the company at \$8.3 billion. The new capital will enable Lacework to invest in more product innovation and pursue strategic acquisitions.

In the announcement of the transaction, Lacework said, "Our growth over the last 36 months reflects the pain many businesses endure as they attempt to navigate the cloud using security products that simply aren't designed for it. This investment, and the partnership of these long-term investors, will help us realize Lacework's promise of becoming the most trusted cloud security platform."
