

VeroSkills Announces \$5.3M Series Seed Financing

VeroSkills will use the new capital to accelerate its rapid growth and further scale its AI staffing engine, which enables employers to fill positions within 48 hours and achieve retention rates two to three times higher than traditional recruitment methods.

In the [announcement of the transaction](#), VeroSkills CEO and Founder Daniel Walsh said, “What staffing and recruitment agencies do in weeks and months, we do in days and hours, thanks to our AI-driven platform. ... There are millions of excellent workers being overlooked by traditional recruiting methods, and VeroSkills has created an effective, first-of-its-kind platform that allows companies to confidently employ them.”
