The company plans to use the new capital to expand into broker-dealer services, broadening the investment products and financial solutions available to members beyond its current RIA platform.

In the announcement of the transaction, Range co-founder and CEO Fahad Hassan said, "The traditional wealth management model is fundamentally broken—slow, expensive, and accessible only to the ultra-wealthy. This new funding ensures we can accelerate our growth—reaching more households, expanding our capabilities, and setting a new standard for what financial advice should look like when powered with hyperfocused AI."
