Gunderson Dettmer advised client ContextLogic Inc. dba Wish on its initial public offering of 46,000,000 shares of Class A common stock at a price to the public of \$24.00 per share for a total of approximately \$1.1 billion in aggregate gross proceeds. Wish's Class A common stock is trading on The Nasdaq Global Select Market under the symbol "WISH."

Goldman Sachs & Co. LLC, J.P. Morgan, and BofA Securities acted as lead book-running managers for the offering.
