For most organizations, this has become inefficient and impractical. And as an industry, we cannot keep building on a broken premise. The future of detection is fundamentally understanding the data sources and having detection engineering baked into the platform with powerful analytics. We help customers differentiate what data is important to their organization, and then we give them a roadmap to become more effective at detecting and mitigating threats."
